### Item 8.01 Other Events.

As previously announced, TRACON Pharmaceuticals, Inc. (the "Company") received notice from the Nasdaq Stock Market LLC (the "Notice") on May 28, 2019, that the Company failed to maintain a minimum bid price of \$1.00 over 30 consecutive business days which does not satisfy the Nasdaq Global Market continued listing requirement set forth in Nasdaq Stock Market Rule 5450(a)(1) (the "Rule").

On November 25, 2019, Nasdaq informed the Company that for the last 10 business days the closing bid price of the Company's common stock has been at \$1.00 per share or greater, and as a result, the Company has regained compliance with the Rule.
