- The common stock was purchased by the reporting person in open market transactions on the transaction date, with a volume weighted average purchase price of \$3.4689. The range of purchase prices on the transaction date was \$3.42 to \$3.57 per share. The reporting person undertakes to provide, upon request by the SEC staff, the issuer, or a security holder of the issuer, full information regarding the number of shares purchased at each price.
- The warrants may not be exercised to the extent that such exercise would cause the reporting person and its affiliates to beneficially own more than 9.99% of the Issuer's then outstanding common stock.
